Personal privacy is very important to Hansard and we are committed to ensuring that personal data is protected at all times in accordance with the Law and to provide certain information to you which is clearly set out within this Statement.

The information and data we collect

In order for Hansard to provide services to our clients as set out in our terms and conditions and/or any agreement or letter of engagement between Hansard and the clients, and/or controllers and personnel of a client in cases where the client is not a natural person, Hansard collects personal data which may include:

- Full name, address, email address, telephone number and other contact information;
- Date and place of birth;
- Nationality;
- Gender:
- Occupation, name of employer, employment history, qualifications, training records;
- Tax residency:
- Due diligence documentation (identification information and documentation i.e. passport, national ID card, driver's license)

- Utility bills, Bank statements;
- Additional information and documentation regarding any political status (i.e. politically exposed persons status);
- Source of wealth and source of funds information and verification documentation;
- Family and business connections, (i.e. next of kin, beneficiaries etc.);
- Beneficial ownership of entities owned by a client or potential client;
- Shareholdings and other assets legally owned by a client or potential client;
- Directorships and information required to be held by any applicable legislation;
- Details of business relationships and organisations which may be connected to a client or potential client;
- Technical data such as your internet protocol ("IP") address and cookies;
- Any other personal information related to an individual, that a client, adviser or other party may provide to us in the course of a business relationship;
- **Special category data** this is data, as listed below that requires extra protection due to the potential harm that may result if this data is mis-used.
- Racial or ethnic origin;
- Political opinion;
- Religious beliefs or similar;
- Trade union membership;
- Physical or mental health or wellbeing;
- Criminal proceedings;

This information is obtained to enable Hansard to fulfil our obligations in accordance with the anti-money laundering and countering the financing of terrorism legislation, the data protection legislation and other regulatory requirements in place in the Bailiwick of Guernsey and to meet our reporting obligations in accordance with the global Common Reporting Standard on Automatic Exchange of Information (CRS) and the Intergovernmental Agreements between Guernsey and the US to implement Foreign Account Tax Compliance Act ("FATCA").

Where we obtain personal information

We collect personal information directly from our clients or potential clients, indirectly from third party sources for example, a legal and/or financial adviser, open source information that is publically available over the internet and personal information received during the course of business with advisers, regulators, both within and outside the Bailiwick of Guernsey, official authorities and service providers, subscribed service sources of risk intelligence and membership registers, as applicable.

How Hansard use personal information and data

Hansard are committed to protecting and respecting your data and privacy and consider looking after people's data a privilege, it is a pre-condition of good business practices. Sharing Data

- Regulatory bodies, to comply with our legal and regulatory obligations our domestic regulator is the Guernsey Financial Services Commission

Hansard may, as part of our ongoing provision of services, be required to transfer personal data outside of Guernsey, the European Union, and the European Economic Area or outside of other jurisdictions assessed by the Guernsey Data Protection Commissioner and/or the European Union as having equivalent and adequate data protection legislation in place.
